

NATIONAL OPEN CALL FOR TENDERS WITH REQUIREMENT OF MINIMUM CAPACITIES N° 03/2025

Operation Title: ACQUISITION OF TWO (02) WATER TANKER TRUCKS OF 10M³ CAPACITY

Mr. the Wali of the Wilaya of Beni Abbés, represented by the Director of Local Administration, is launching a National Open Call for Tenders with minimum capacity requirements regarding:

ACQUISITION OF TWO (02) WATER TANKER TRUCKS OF 10M³ CAPACITY

- The bidder must hold an electronic trade register containing the activity code for the operation.
- Candidates must be manufacturers, authorized dealers, or importers having completed at least one project in the field, justified by a certificate of satisfactory execution issued by public contracting authorities.

The companies interested in this call for tenders can withdraw the tender documents (cahier des charges) from the **Direction de l'Administration Locale of the Wilaya of Beni Abbes located at Rue Elmodjahid Lamtouech Bahous Beni Abbes.**

The tender documents must be withdrawn by the bidder or their duly appointed representative; in the case of a consortium, the tender documents must be withdrawn by the lead partner or their duly appointed representative. The file submitted by the bidder must be composed of **Three envelopes** as follows: *Candidacy file *Technical offer envelope *Financial offer envelope (according to the requirements contained in the tender documents) and must be inserted into a sealed anonymous envelope bearing only the following mentions:

Presentation of offers:

The candidacy file: the documents required in the tender documents (article 11 page 07 and 08).

The technical offer: the documents required in the tender documents (article 11 page 08).

The financial offer: the documents required in the tender documents (article 11 page 08).

The duration for the preparation of offers is **fifteen (15) days** starting from the date of the first publication of this call for tenders in the BOMOP or one of the national daily newspapers.

The bid submission date is set for the last day of the preparation period at **12:00 PM**; this date is postponed to the first working day if the submission day coincides with a public holiday or a legal day of rest.

Bidders are invited to attend the opening session of the envelopes (candidacy, technical, and financial) in a single public session, which will take place on the day corresponding to the last day of the preparation period at **2:00 PM (14:00h)** at the headquarters of the Direction de l'Administration Locale of the Wilaya of Beni Abbes. If this day coincides with a holiday or a legal day of rest, the opening of the envelopes will be postponed to the following working day at the same time (2:00 PM).

Bidders will remain committed to their offers for a duration equal to the preparation period plus **three (03) months** starting from the bid submission date.
